FREQUENTLY ASKED QUESTIONS

What is NAFCU/PAC?

Founded in 1976, NAFCU/PAC is NAFCU's Political Action Committee. The goal of NAFCU/PAC is to help credit unions have a united voice in the political process. NAFCU/PAC raises voluntary funds from executives, volunteers and staff of NAFCU member credit unions for use as campaign contributions to candidates and members of Congress. NAFCU/PAC is a major component of NAFCU's advocacy efforts on Capitol Hill.

Why should I support NAFCU/PAC?

NAFCU/PAC is the political arm of NAFCU. Your contributions are used to help support and elect candidates and members of Congress who understand the important work that credit unions do.

Who does NAFCU/PAC support?

NAFCU/PAC is completely independent and bipartisan. We support candidates whose issues are aligned with credit unions. We do not get involved in the presidential campaigns, we focus instead on federal lawmakers on Capitol Hill.

Does my contribution matter?

Yes. Together we can build a strong PAC that supports the needs of the credit union industry. Your participation in NAFCU/PAC is a critical part of achieving our advocacy goals.

Can our members participate in the "I ♥ My Match" payroll deduction program or is it just for credit union staff?

The "I ♥ My Match" payroll deduction program is currently only for employees of NAFCU member credit unions. Your members can still participate with NAFCU/PAC and the Children's Miracle Network through separate programs sponsored by your credit union. Contact NAFCU's Political Affairs staff for great ideas!

Can our employees write off the charitable contribution made in their name?

No. Due to Federal Election Commission (FEC) regulations, NAFCU and/or NAFCU members contributing to NAFCU/PAC are prohibited from benefiting from these contributions.

Is there a limit of how much a person can contribute a year?

Yes. Current FEC regulations allow an individual to contribute up to \$5,000 per calendar year to a trade association's Political Action Committee.

Suggested Payroll Deduction Levels

The following are suggested payroll deduction levels based off of salary and are in compliance with FEC regulations for maximum donation levels. When contributing to NAFCU/PAC every dollar counts, whether it is \$1 or \$100 per pay period the money will be used to help credit unions advance their efforts and make a major impact in the political process.

NAFCU/PAC is a voluntary non-partisan Political Action Committee of the NAFCU and is used for federal election purposes. Contributions or gifts to NAFCU/PAC are not tax deductible as charitable contributions for federal income tax purposes. Federal law prohibits NAFCU/PAC from accepting contributions from foreign nationals. All contributions must be personal. Federal law prohibits any contributions from a corporate treasury fund or corporate account.

RULES AND REGULATIONS

- The credit union can only solicit contributions from the employees of a NAFCU member credit union and citizens of the United States.
- 2. All contributions are voluntary and all employees have the right to refuse to contribute without fear of job discrimination or financial reprisal.
- Credit unions must keep the original signed "I ♥ My Match" payroll deduction authorization form for each of their participating employees.
- 4. Employees may withdraw their participation in the "I ♥ My Match" payroll deduction program at any time by sending an email or letter to their credit union. Federal Election Commission (FEC) regulation states that after this withdrawal, the credit union must hold on to the original authorization form for 3 years.
- 5. The credit union is responsible for providing NAFCU/PAC with the name, home address, occupation and amount of each employee participating in the "I ♥ My Match" payroll deduction program to stay compliant with FEC regulations.
- NAFCU/PAC will be responsible for filing all federal campaign finance reports and information associated with the "I ♥ My Match" payroll deduction program.
- 7. FEC regulations require that single contributions of \$50 or less be forwarded to NAFCU/PAC within 30 days of receipt and single contributions greater than \$50 be forwarded to NAFCU/PAC within 10 days of receipt.
- 8. Employees may contribute a maximum of \$5,000 per calendar year. Any instances of contributions above that amount will be refunded to the employee by NAFCU/PAC.
